New Constitution for the Green Party of England and Wales

The current Constitution, which was suitable for a small political party, is not longer suitable for the sizeable Party that we have today. However, reaching agreement on what that new structure and Constitution should be is not so easy.

Special Interest Groups

Green Party Seniors is one of the so-called "Liberation Groups", now called Special Interest Groups (SIG) within the Green Party.

The Co-Chairs of SIGS meet every so often to discuss matters of mutual interest.

GPEW Strategy and finances seem to concern all the groups. SIGs Co-Chairs have been concerned for some time that the Party strategy is concentrated on winning Council seats and more MPs, and that setting targets is not a strategy.

The Party has more staff than ever who are mostly concerned with elections and external and internal messaging with little joined up thinking.

We don't run campaigns - which many of us feel is a mistake. How will people vote for us if they don't know what we would do once we are elected?

Attached to this email is the Strategy. Attendees at the SIGs meeting agreed to acquaint ourselves with it. I will keep you informed of our discussions.

Autumn Conference

1 Where, when and how? Harrogate, 30 Sept-2 Oct 2022

This will be a hybrid Conference, meaning that memebers can attend in person or via Zoom. This is the most expensive option but is the one preferred by members as it gives everyone a chance to attend however suits them best. It requires a lot of organisation and staff support at the venue, hence the expense.
