I've been a member of Policy Development Committee (PDC) since the end of 2021, initially as a co-optee, and since last summer as an elected member. During this time I've worked closely with half a dozen very varied Policy Working Groups (PWGs), from getting them off the ground in the initial stages to supporting them in taking policy papers to Conference.



Apart from this hands-on work with PWGs, I've been involved in the accreditation of Conference policy motions (those which become C motions on the agenda), and for a time was a member of the manifesto working group looking towards the next general election. I've also been closely involved in the organisation of Policy Fest events, including supporting PWGs in preparing their presentations, and chairing and providing technical support for sessions. As a PDC member I also attend national Conference, giving policy advice as required, and on the odd occasion proposing a motion.

The role of PDC member entails absorbing a large amount of detailed procedural knowledge, and a sound overview of both the existing policy website and of what's coming down the track. Although I've been doing the job for a while, I acknowledge that there is always more to learn, and I'll continue working to increase my level of knowledge.

In a past life I was a city councillor in Cambridge, during my misguided youth as a Labour Party member. I joined the Green Party nearly 20 years ago, and became actively involved some 13 years ago. As well as being on PDC, I am currently joint co-ordinator of my local party, South Lincolnshire, and of my regional party, East Midlands, and believe I've played a part in helping both to grow and develop


I have a thorough understanding of the Green Party's values and policies and procedures. I now work part-time and am able and willing to commit the necessary time and energy to Policy Development Committee.

I took up a volunteering position at the Brighton & Hove Green Party in 2018 and have been involved ever since. I have worked for the Brighton & Hove Green Party, in membership support and campaigns, and the national Green Party. I currently work for a trade union, and in local government, supporting Green Party councillors with a variety of tasks including research, consultation responses and speechwriting. I recently completed some paid and voluntary work as part of Caroline Lucas's constituency and parliamentary teams. Due to holding two part-time positions,



I have a four-day week, and would like to dedicate my time to volunteering for the Green Party again.

I am familiar with analysing and developing policy at local and national levels. Having worked on a General Election (2019), PCC Election (2021) and multiple by-elections at the Brighton & Hove Green Party, I have developed detailed knowledge of the policy positions of each of the major political parties. This was crucial to translating complex ideas into concise communications with potential voters: through direct contact, responding to campaign pledges, and writing canvassing scripts. While at the national Green Party, I compiled the 2019 General Election report. This included summarising focus group feedback and analysing data trends. During my time in the Young Greens, I developed a firm understanding of the roles of our liberation and special interest groups.
